



## ALTERNATIVE SENTENCING SCHEDULE OF FEES Effective 1/1/2016

Pursuant to NRS 211A.130 this Schedule of Fees applies to all probationers and supervised releasees assigned to the Henderson Alternative Sentencing Department. Unless noted below, all fees can be paid in monthly installments if financially necessary.

- All ASD probationers will be required to pay the ASD fees listed below (Post Sentencing).
  - \$50.00 per month direct supervision fee  
(This fee may be reduced or waived by the Chief if the offender's financial situation can be verified as being below the current poverty guidelines as determined by the state of Nevada.)
  - \$40.00 per month indirect supervision fee  
(This fee may be reduced or waived by the Chief if the offender's financial situation can be verified as being below the current poverty guidelines as determined by the State of Nevada.)
  - \$45.00 community service fee  
This is a one-time set up fee that must be paid within 60 days of sentencing. This fee may only be waived by the Chief if deemed financially necessary.
  - \$45.00 work program fee  
This is a one-time set up fee that must be paid within 60 days of sentencing. This fee may only be waived by the Chief if deemed financially necessary.

### **Additional Program Fees**

- Substance Abuse/Alcohol (DART) testing fees:
  - \$25.00 per week ordered to testing
  - \$30.00 drug test confirmation fee (per drug confirmed, upon denial of probationer – this fee is not charged if drug is not confirmed)
  - \$60.00 Drug Patch fee – per patch (Maximum 10 Days Per Patch)

- Consistent Alcohol Testing (CAT) testing fees:
  - \$75.00 per week ordered to testing
- House Arrest/GPS Monitoring fees:
  - \$75 Setup Fee
  - \$15 per day ordered (Sliding Scale Applies for those meeting financial waiver standards)
- SCRAM Device fees:
  - \$75 Setup Fee
  - \$15 per day ordered (Sliding Scale Applies for those meeting financial waiver standards)
  - \$50 per month Ethernet or Cellular Modem fee (optional)
- Anger Management Program: \$140
- DUI School Fee (Formally HAAP): \$225
- Substance Abuse Counseling Fees (REACH Program):
  - \$20 Per Session
  - \$50 enrollment fee (Payment Plan Offered for those meeting financial waiver standards)
- Chemical Dependency Assessment (CDA) fees:
  - \$125 (paid in advance)
  - \$200 Rush Fee (CDA Completed less than 7 days from court date)
  - \$150 In-custody CDA Fee (Fee for In-custody CDAs)
  - \$50 Reschedule fee
  - \$25 Lost materials fee
- First Offender Program
  - \$150 per program
