NOTICE OF HOUSE ARREST/SCRAM[®]

PROGRAM REQUIREMENTS

- YOU ARE REQUIRED TO IMMEDIATELY REPORT TO THE HENDERSON ALTERNATIVE SENTENCING DEPARTMENT (ASD) AFTER LEAVING COURT. THE HENDERSON ALTERNATIVE SENTENCING DEPARTMENT OFFICE IS LOCATED IN THE BASEMENT OF THE COURTHOUSE. IF YOU FAIL TO IMMEDIATELY REPORT, YOU WILL BE SUBJECT TO IMMEDIATE ARREST FOR A NEW CHARGE OF A PROBATION VIOLATION UNDER NRS 211A. IF THE HENDERSON ASD IS UNABLE TO LOCATE YOU, A NO BAIL BENCH WARRANT WILL BE REQUESTED FOR YOUR IMMEDIATE ARREST.
- THE HOUSE ARREST AND SCRAM[®] PROGRAMS COSTS \$15.00 PER DAY WITH AN INITIAL SETUP FEE OF \$75.00. PAYMENT IS REQUIRED AT THE TIME OF ENROLLMENT. YOU MAY PAY WITH CASH, CREDIT CARD, DEBIT CARD OR MONEY ORDER DURING NORMAL BUSINESS HOURS. YOU MAY PAY WITH CREDIT CARD, DEBIT CARD OR MONEY ORDER OUTSIDE OF NORMAL BUSINESS HOURS (MONDAY-THURSDAY 8AM TO 5PM). IF YOU HAVE ANY QUESTIONS ABOUT PAYMENT, YOU CAN DISCUSS THAT WITH YOUR ATTORNEY IN COURT. IF YOU FAIL TO PAY THE MINIMUM AMOUNT DETERMINED REQUIRED BY THE HENDERSON ASD THEN YOU WILL BE TAKEN INTO CUSTODY AND RETURNED TO THE HENDERSON DETENTION CENTER TO SERVE THE REMAINDER OF YOUR SENTENCE AS SPECIFIED IN YOUR SENTENCING ORDER IF ORDERED TO HOUSE ARREST. IF ORDERED TO SCRAM[®] YOU WILL BE RETURNED TO COURT.
- YOU WILL BE REQUIRED TO SIGN AND ADHERE TO *THE HOUSE ARREST PROGRAM AGREEMENT AND RULES/SCRAM[®] PROGRAM AGREEMENT*. IF YOU FAIL TO AGREE TO OR SIGN THESE RULES, YOU WILL BE IMMEDIATELY TAKEN INTO CUSTODY AND RETURNED TO THE HENDERSON DETENTION CENTER TO SERVE OUT THE REMAINDER OF YOUR SENTENCE AS SPECIFIED IN YOUR SENTENCING ORDER FOR HOUSE ARREST OR RETURNED TO COURT FOR SCRAM[®].
