

ORDINANCE NO. 1235

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HENDERSON TO AMEND THE TITLE OF ORDINANCE NO. 1227 ADOPTED FEBRUARY 5, 1991 AND OTHER MATTERS RELATED THERETO.

CITY COUNCIL OF THE CITY OF HENDERSON DOES ORDAIN:

- tion 1: the City Council did adopt Ordinance No. 1227 on February 5, 1991; and
- tion 2: The title, as adopted, did not establish new Henderson Municipal Code Chapters 15.32, 15.33, and 4.92; and
- tion 3: the title of Ordinance No. 1227 is hereby amended to read:

AN ORDINANCE TO AMEND THE TITLE OF ORDINANCE NO. 1227 TO READ AN ORDINANCE REPEALING HENDERSON MUNICIPAL CODE CHAPTER 15.32 AS ESTABLISHED BY ORDINANCE NO. 83 CONCERNING THE AUTHORITY AND DUTIES OF THE FIRE CHIEF, ORDINANCE NO. 872 AND 873 CONCERNING THE ADOPTION AND AMENDMENTS OF CERTAIN FIRE CODES AND STANDARDS BY REPEALING ORDINANCES NO. 83, 872 AND 873; AND REPEALING CHAPTERS 4.92 AND 8.86 OF THE HENDERSON MUNICIPAL CODE SETTING FORTH REGULATIONS GOVERNING FIREWORKS IN THE CITY OF HENDERSON AND SETTING FORTH A NEW HENDERSON MUNICIPAL CODE CHAPTER 15.32 ADOPTING THE 1988 EDITION OF THE UNIFORM FIRE CODE TOGETHER WITH SUPPLEMENTAL DOCUMENTS, SETTING FORTH A NEW HENDERSON MUNICIPAL CODE CHAPTER 15.33 CONCERNING FIREWORKS, AND SETTING FORTH A NEW HENDERSON MUNICIPAL CODE CHAPTER 4.92 CONCERNING FIREWORKS SALES AND OTHER MATTERS RELATING THERETO.

- ection 4: This ordinance does not affect the effective date or provisions of Ordinance No. 1227.
- ection 5: If any section, subsection, paragraph, clause or provision of this Ordinance shall for any reason be held invalid or unenforceable, the invalidity or unenforceability of such section or subsection, paragraph, clause or provision shall not affect any of the remaining provisions of this Ordinance.
- ection 6: All ordinances, or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Henderson, Nevada, in conflict herewith are repealed.
