






- The City continues to view online services as a means to allow citizens to interact with the City anytime and anywhere and is committed to having more folks online rather than in line.

CANTEEN COMMISSARY

The new Canteen Commissary System for the Henderson Detention Center allows inmates, and others, to put funds into an inmate's account which enables them to purchase products such as hygiene items, snacks, writing instruments, etc. while housed at the Detention Center. Inmates can add funds to the account during the booking process using the Booking Cube. Friends and family of inmates can add funds to the account via a Lobby Kiosk and/or a website.






CANTEEN COMMISSARY

- Funds remaining on account are placed on a 'debit card' and given to the inmate upon release.




The Portals for the Henderson Municipal Courts allow the public and Defense Attorneys to view information about court cases.






Public and Attorney Portal for Courts


