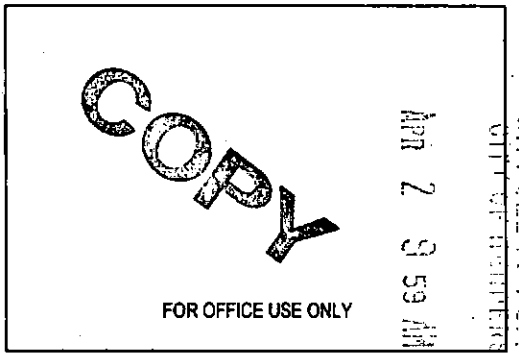

Since I must give my answers under penalties of perjury and cannot, therefore, qualify my answers I am answering the 16 questions asked on the attached form by following the description of lawful money as found in the Constitution of the United States of America in Article I, Section. 10. No State shall enter into any Treaty, Alliance, or Confederation; grant Letters of Marque and Reprisal; coin Money; emit Bills of Credit; make any Thing but gold and silver Coin a Tender in Payment of Debts; pass any Bill of Attainder, ex post facto Law, or Law impairing the Obligation of Contracts, or grant any Title of Nobility.

I know of no other Constitutional definition of "Monetary, cash or \$" that would expand the Constitutional restriction on the States for money.

If I am in error in my belief concerning what the Constitutional meaning of "Money" is please supply the Constitutional amendment that has changed Article I, Section 10.

NRS 294A.120

(c) The 15th day of the second month after the general election, for the remaining period up to 30 days before the next regular session of the legislature, list each of the campaign contributions that he receives during the period on forms designed and provided by the secretary of state pursuant to this section and NRS 294A.362. Each form must be signed by the candidate under penalty of perjury.
