No. 4 – Summary of the comments gathered and of any workshop held regarding the proposed ordinance:

No comments were received.

No. 5 – Estimated economic effect on businesses by the proposed ordinance:

a. Explain the adverse and beneficial effects:

The proposed ordinance amends an industry specific regulatory framework that provides a legal structure on how to operate within the City of Henderson. This has both an adverse effect in that some actors will not want to conform to the updated HMC, and a beneficial effect by increasing the number of available licenses to certain operators. Another benefit for the community is that this proposed ordinance will curtail the sales of illegally obtained scrap metals.

b. Explain the direct and indirect effects:

The direct effects of implementing the proposed ordinance will be the increase of the maximum number of licenses issued for certain types of secondhand dealers. This will potentially increase competition for these specific licensees. For certain specific secondhand transactions, extra steps and limitations on purchases will be required and are all also a direct effect. Other retailers would be required to comply with reporting requirements under NRS Chapter 647, but would not need to submit to a background investigation in order to obtain a Henderson Business License. No indirect effects have been identified.

c. Number of businesses likely to be affected by the proposed ordinance

Variable. This would be dependent on the number of applicants and that number cannot be determined at this time.

No. 6 – Describe the methods considered and/or used to reduce the impact of the ordinance:

The proposed ordinance includes provisions to increase the number of certain specific secondhand dealer licenses available. The proposed ordinance also has a classification of secondhand dealers that will no longer be required to submit to a background investigation.
