TITLE: SERVICE & MAINTENANCE OF PRIVATE FIRE HYDRANTS

#### **PURPOSE:**

To standardize the testing and maintenance of private fire hydrants.

**REFERENCE:** 2018 IFC § 507 & § 507.5.7.1 as amended

#### **RULES & REGULATIONS**

(Private Fire Hydrants Servicing Agreement form is attached)

- I. A renewable permit is required for facilities that have private fire hydrants. (2018 IFC, as adopted, Section 105.6.39)
- II. Information and expectations for all approved companies.
  - A. Minimum Criteria for Approved Companies
    - 1. All hydrants shall be serviced to the satisfaction of the Building and Fire Safety Department, Fire Inspection Section, hereafter known as the FIS, on an annual basis
    - 2. All businesses shall maintain a City of Henderson Business License
    - 3. The property owner shall be responsible for hydrant service and record maintenance
    - 4. Within 48 hours, copies of reports listing deficiencies shall be forwarded to the FIS office by the servicing business
    - 5. Report copies shall be on site and available to the Fire Safety Inspection Section when requested
    - 6. All services performed shall be noted on the service report.
    - 7. Technician shall use tools as specified by the manufacturer for hydrant servicing
    - 8. The Henderson Police Dispatch Center shall be notified when any private hydrants are out of service and when they are returned to service.

  - B. Minimum information which a service report shall contain:
    - 1. Name, address and City business license number of Company servicing hydrants
    - 2. Name and address of the site being serviced signature and title of site representative
    - 3. Name, address and phone number of the management company or person

- responsible for maintenance
- 4. Date of service and name of servicing technician
- 5. Number of hydrants serviced
- 6. Location of all hydrants with deficiencies
- 7. Identification of all hydrants that are out of service
- 8. List of items and/or processes checked as part of the service

#### C. Minimum Items and/or processes required to be checked during annual service

- 1. Hydrant not obstructed; minimum distance 36" from circumference of the hydrant body
- 2. Hydrant paint color and condition; all private hydrants shall be painted with safety red enamel paint
- 3. Hydrant barrel condition
- 4. Hydrant direction; large port shall point toward the street or fire apparatus access road a.k.a. fire lane
- 5. Break-away pad condition
- 6. Blue reflector; located in the street in front of the hydrant
- 7. Ensure Red Painted curb is 15' on either side of the hydrant (Per State Law NRS484B.450. Parking shall not be within 15'-0" on either side of a fire hydrant. This zone shall have the curbs painted.)
- 8. Caps & gaskets in place; shall seal & screw on & off smoothly
- 9. Hydrant threads and mechanisms shall be lubricated; a food grade lubricate, meeting hydrant manufacturer specifications shall be used
- 10. Operating nut condition, no excessive wear or rounded corners
- 11. Flow hydrant fully to remove brackish water
- 12. Open and close hydrant fully in both directions; mechanism shall function smoothly
- 13. Visible signs of underground leakage
- 14. Hydrant drains properly; weep holes not plugged
- 15. Hydrant street valve shall be closed & opened; the valve shall be left it in the full open position
- 16. Vehicle protection bollards (impact protection); functional and maintained in good condition
- 17. All out-of-service hydrants shall be marked with a ring on the large port, or other signs approved by the Henderson Building and Fire Safety Department, indicating the fire hydrant cannot be used. An out-of-service hydrant shall be defined as not repairable at the time any deficiencies are identified.

### **Service & Maintenance of Private Fire Hydrants**

All companies servicing and/or testing private fire hydrants shall obtain written authorization to perform such services from the jurisdiction. Please send this form to Fire Safety Inspection Section.
